

This is my teenage reality

Being a teenager can be tough for anyone. Navigating relationships with your family and friends, knuckling down at school and trying to work out what you want to do when you 'grow up'. Imagine how much more difficult all this is when people write you off because you live in a 'slum' neighbourhood, you have a chaotic home life and you are just finishing a two-year sentence in juvenile detention.

When we met 17-year-old Dario, he was in exactly this situation.

"You get out and you try to get a job but no one will give you one. You have nothing to do, nowhere to live and nothing to eat. So then what? You might really want to change your life, but then you have to face the reality of your situation. And this is my reality - I don't have any family and I was stigmatised because everyone knew I'd been in a specialist facility and so, yeah, I found myself reoffending. I wanted to do the right thing and leave that life behind; it was so frustrating that I didn't have the opportunity. I think it'd be so great if they could help you prepare for when you leave and then check up on how you're getting on."

We have listened to Dario and other young people in his position. This year, we will start running a project that provides practical and emotional support to children while they are in detention facilities as well as guidance and access to services after they leave.

Now, we just need your support to help make this work possible.

Children in detention

There are around 4,000 adolescents (aged 14 and above) in penal detention facilities in Colombia. There are thousands more detained in secure children's homes. The vast majority of these young people are from marginalised neighbourhoods in Colombia's large cities.

Over the past 3 years, we have been working with our partner Tiempo de Juego to address the needs of young women within both types of detention facilities in the Colombian capital, Bogotá. Almost all these young women told us that, before being detained, they had lived on the streets, had had abusive relationships and developed substance addictions. Many were from single parent families and had assumed the role of 'provider' at a young age. Too young to get a job, they became involved in gangs and petty crime to make money.

While young people are in detention, the problems that led them there do not go away. For instance, Colombian Social Services does not support their families to address the problems that contributed to their child's detention. There are guidelines for the psychological and life skills support that young people should receive whilst detained, however, our experience has shown us that the quality of this support varies widely between centres. This means that when many young people reach the end of their sentences, they do not have the skills, self-confidence or support networks that would help them build a new life for themselves. After leaving detention, they receive no follow-up support.

"Companies should offer us opportunities. They shouldn't shut their doors to us because we don't have certified experience. If we've showed that we're hardworking and committed during our sentence, they should take us on, train us and give us a job."* "Some kids get out and they have family waiting to support them. That's cool, but what if you don't have a family?"*

Learning from our experiences

Those of you who have supported us for some years may remember that we have previously worked with children and young people as they prepare for leaving institutional care. From 2010 - 2015 we supported our partner AIMY in Bogotá to develop a highly successful programme that enabled families to provide a safe and stable environment for their child when they returned home after being in care. In Cali, starting in 2004, we helped another partner, Formación de Futuros, provide young adult care leavers with friendly advice, practical skills training (cooking, cleaning, money management) and a place to call home.

Our experience with these two partners, in addition to what we have learnt through our work in detention centres over the past three years, has showed us that on-going, personalised accompaniment is fundamental to young people's successful reintegration into their family and community and their ability to access education or employment.

So, over the next three years, in continued partnership with Tiempo de Juego, we will run a new project which will ensure that young people across Bogotá receive this type of accompaniment as they prepare to leave detention.

Improving life chances of young people

As of this year, we are working in four juvenile detention and secure children's homes in Bogotá, with 160 adolescent boys and girls. Weekly activities will help these young people heal from traumas they experienced before and during their involvement in crime and will help them make positive, informed decisions about their futures. Echoing the approach of many successful reintegration programmes across the globe, many of the Tiempo de Juego team "My main fear was of being judged. I committed a serious crime and some of my family don't recognise that I've changed... Moving home has been tough."*

running the project are from similar backgrounds to the young people. Their determination to help them break the cycle of violence and crime in their communities is extremely inspiring.

We will also work with the young people's families, helping them to improve their relationships with their sons and daughters so that they are better able to support them in the future.

The project will work, too, with staff at the detention centres, to convince them of the benefits of a less punitive, more therapeutic and educational approach to working with young people. We hope that by the end of the project, the staff will be able to provide this support without our input.

We will also build a network of service providers - healthcare, employers, colleges and sports clubs - to help them break down the barriers that exclude ex-young offenders from accessing the lifechanging opportunities that exist within their city. We will run events within the detention facilities where these organisations can reach out to young people as they prepare to leave detention and encourage them to enrol in their services.

By working in this way, building capacity within detention facilities and wider society to understand and respond to the needs of ex-young offenders, we will improve the life chances of many hundreds more young people than those we reach directly through this project, and for many years more to come.

One of CCC's aims is to strengthen children's organizations in Colombia, so it was great to see the professionalism and authority with which TDJ presented our joint project."

"In November I went on a three-day learning retreat in Nepal with 19 civil society leaders from around the world, brought together by one of our donors. The aim of the retreat was to explore key concepts used in development such as leadership, sustainability and measuring change, and what these mean for our work in practical terms. The group was diverse both geographically, with participants from four continents, and in terms of focus, with expertise ranging from climate change to health care and, of course, children's rights. This diversity brought real strength to all of our discussions and reminded me that however different we are, we as NGOs are also a community and we are stronger and more effective when we work together and share our knowledge and expertise."

Letter from the Director

Dear Friends,

Some of you don't know me yet. I am Ángela Carreño, the new Executive Director of Children Change Colombia. I would like to thank all the staff, partners, Board members, our patron, Fernando Montaño and supporters for the warm welcome I have received in my new position.

So to introduce myself, I have 13 years of experience working in the international development and humanitarian field and I am very pleased to be taking on this new challenge to lead the biggest UK organisation that works exclusively in Colombia, my homeland.

During the past few months, the CCC team and our local partners in Colombia have been working really hard to cope with the economic and social effects of the pandemic and the lockdown. New online methodologies have been developed so that are partners are able to continue working with the children, adolescents and communities of the current projects. We also went the extra mile and launched the "Help Colombia Covid-19 Campaign" to support the most affected families of the communities our partners work with, and we are very pleased to say it was a resounding success.

We had the goal of raising £8,500, yet thanks to your support we managed to raise £12,000! Overall, we're really pleased to say we've supported 2,933 people.

So far, with your support we've been able to:

• Provide housing support to keep a roof over the heads of 19 families in Bogota

• Support 170 families in Bogota and Quibdo with food and toiletries.

• Continue providing remote psychosocial support for 332 children and young people, keeping them safe from the risks that have increased as a result of the pandemic.

• 125 dignity kits including sanitary items for girls and adolescents in Quibdo.

• Personal Protective Equipment and first aid kits for 12 communities in Choco.

We have already started planning with local organisations to continue supporting the families most affected by the crisis in Colombia and adapt the future projects to be able to support children in Colombia in the new global context.

On behalf of everyone at Children Change Colombia, I would like to thank our amazing CCC community for all your support during these difficult times – we know it hasn't been easy and yet you have still managed to support us so well! I also want to reassure you that our commitment to children and young people in Colombia continues, even more so now in such troubled times.

Colombian diary

Simon Terrington, a British supporter based in Colombia explains why CCC is important to him.

"I am very pleased to be supporting Children Change Colombia. Having supported one or two other charities in Colombia previously, I was looking for the opportunity to work with a reputable, well-run charity that is clear and transparent about where the donations go and how they make a difference. I like the fact that CCC have projects throughout Colombia, therefore helping different vulnerable communities. Being a dad myself, the work CCC do with children who are in terrible situations is close to my heart.

I have visited two of CCC's projects, one working to prevent gang recruitment and another that protects children from sexual exploitation. I visited the latter with Blanca from CCC's Colombia office - we met some young women who told us about the problems they face because their neighbourhood is a 'tolerance zone' for sex work. We also listened to some children sing and took part in a band practice. Both visits were very inspiring!

I have taken on the role of Community Ambassador for CCC, based in Bogotá. Last September, Blanca and I organised a sponsored walk during Ciclovía in Bogotá - this is when the city's main roads are closed off to cars every Sunday and cyclists and pedestrians take over! There were over 30 attendees. We walked 10K and then had a great Sunday Roast at El Café Inglés (The English Café). I also helped CCC win two grants from the company I used to work for, which are helping to fund one of their projects.



My aim is to organise a couple more activities this year to continue supporting CCC. It's a fantastic charity and it's good to be able to give something back to the community."
