

An impossible dilemma

Don Jaime lives with his sons Andres and David, aged 9 and 11 in a rundown building, in one room with one window. That window has to be covered with a blanket. They live in Bogota's 'tolerance zone' for sex workers, who gather on the street below their room. The blanket blocks out the light but it also blocks out the street scene below, giving them at least one place where they can just be children and forget about their surroundings. Don Jaime has to work to put food on the table, but he also has to accompany his sons every time they leave their room; the streets are simply not safe and there's no-one he trusts to look after them. Every day he faces an impossible struggle between keeping his sons safe and keeping them fed.

"Raising children here is exhausting. I dream of a future where my sons and I are a happy family together"

"Since my wife was committed to a psychiatric unit 6 years ago I've had to be both mum and dad. It hasn't been easy. Raising children here, surrounded by drug use, prostitution and crime is exhausting. I always have to be with my children, making sure no-one with bad intentions comes near them and that they don't learn bad things. Since they joined ACJ's project our lives have got so much better -ACJ have helped me to be a better dad, my sons are doing well in school and in the project they learn to understand what they see on the streets and how to protect themselves from it. I dream of a future where my sons and I have our own house and we are a happy family together."

Don Jaime represents just one of many families in this area that are determined to keep their children safe from the dangers that surround them.

How to reduce the risks to children

Commercial sexual exploitation of children (CSEC) continues to be a significant problem in Colombia. Between 2011 and 2013 Colombian Social Services removed 2,135 children from situations where they were being sold for sex. 45% were under 11 years old. Organisations working in this field have estimated that over 35,000 children are involved in CSEC in Colombia but large numbers of cases go unreported.

Bogota has some of the highest levels of CSEC in the country, and Santa Fe and Martires are two of the zones in Bogota with the highest levels of CSEC. It is believed that the risks are so high there because of the very visible presence of sex workers. Santa Fe is a designated 'tolerance zone' where sex workers are permitted to operate without prosecution and can be seen in large numbers at all hours of the day. This means that just on their way to and from school children pass groups of sex workers, and people who pay for sex, on the streets. The potential risks of this are:

- Children see sexual exploitation as a normal transaction in exchange for money or goods. In a neighbourhood where many families are living in poverty, this is a dangerous message.
- Many children in the area have a parent or other family member involved in sex work or sexual exploitation, which can further increase the likelihood that they see the sale of their own bodies as normal.

- There is a complete lack of police presence in the district, which has created spaces for gangs and drug dealers to operate openly. This exposes children to potentially dangerous adults who seek to violate their rights – this includes those who recruit and control adults and children for sexual exploitation, those who pay for sex, and those involved in gangs, drugs and other crime.
- It is more difficult to identify children who are being sexually exploited for money when there are so many adults in this situation. Children are often placed on the streets with false documents stating that they are over 16, the legal age for sex workers.

All these factors combine to create an extremely high risk of CSEC and other forms of physical and sexual abuse. There are many parents like Don Jaime who are doing their best to make sure that their children are protected against this, but they can't do this alone.

What are we doing?

Children Change Colombia began working with ACJ Bogota this year to reduce children's risks of abuse. 120 children from these communities are learning about the different forms that CSEC can take and what to do if threatened by it. They also learn that CSEC is not normal but a violation of their rights, and that they are not to blame if they experience it. Young adults who are already involved in sex work/sexual exploitation are also participating in activities to help them gain the confidence to escape it, find other ways to earn money, and where necessary to provide support to their own children. In addition to this, ACJ is working in nearby schools to raise awareness of CSEC among students and teachers, and to make sure that teachers know what they should do to protect children.

To encourage long-term protection of children, community members, including street vendors and shopkeepers, are taking part in activities to raise their awareness of CSEC, enabling them to identify it when they see it happening and encouraging them to take action to stop it.

Successful experiences

Children Change Colombia has experience of working on this type of project. You may recall that from 2010-2015 we worked with Renacer to prevent and reduce CSEC in Cartagena, an area with high levels of 'sex tourism'. This project was a huge success, directly reaching 333 children and enabling Renacer to mobilise the whole community to take action to protect children from CSEC.

Through working with 276 teachers and 181 public servants in the District, Renacer was able to a) create a public sector that is significantly more aware of CSEC, where there is less prejudice and stigma surrounding the issue and b) improve the care available for those who experience CSEC. These public officials are now capable of taking independent action to protect children against CSEC and to care properly for those who have already experienced it. During the period, they also provided training in CSEC to a further 932 teachers, 6,554 children, and 1,347 parents.

20 young people were able to develop leadership skills and joined a network dedicated to combating CSEC. They now play an active role in protecting other children from CSEC, sharing what they've learnt with their communities and teaching others what can be done to prevent it.

We hope that our experience with Renacer and the lessons that we learnt during that 5 year project will complement the experience of ACJ Bogota and that together we can increase children's protection from CSEC.

25 years of CHILDREN CHANGING

Our work is not really about numbers. Our emphasis has always been on the quality of our work so that we can be sure we are making long-term improvements in children's lives.

Just counting the children and families we have worked with, for example, tells you little about whether we've really made a permanent difference.

In all our newsletters, on our website and elsewhere we try hard to show you how the work that you support leads to genuine long term changes. Where we can, we try to illustrate this with real stories, of real people like Jaime, Andres and David's story on the front page.

But sometimes, of course, numbers do help, especially when you're trying to grasp the scale of something. And the scale of what we have achieved over the last 25 years, with your help, is immense!

How many children and adults have we reached?

It is difficult to be absolutely precise about this figure for a number of reasons: For example, some figures from our early years are a bit difficult to come by. Also, we didn't always make the distinction between children who we have worked directly with and children whose lives are affected indirectly by our work. We may work with one child on a programme to return them safely to their family after life on the street. But if we help their family stay together, their brothers' and sisters' lives are changed too.

Based on the figures that we do have, we estimate that at least **1,072,000 children and adults** have been affected significantly by our work over the last 25 years.

How many partner organisations have we worked with?

We aim to work on the issues that others overlook, so that means we are always seeking living, landmines, HIV and Aids, educational new partners who have the knowledge and expertise to make a real impact on the issues that are really affecting children's rights.

Since 1991 we have supported **46** partner projects on issues as diverse as child labour in the coffee industry and child sexual

exploitation in the tourist industry, street inclusion for children with disabilities and the social exclusion of young people leaving care. We have always helped to put such neglected issues on the map, so that once we move our limited resources elsewhere our partners' work on these issues, and that of others, can continue to flourish.

How much money have we raised?

Up to the end of 2015 we had raised a staggering £11,610,78

Our highest ever annual income was £727,032, which we achieved in 2011. This was nearly matched by 2015's income, which was £725,219.

In fact, since 1991 our annual income has generally been on an upward trend, thanks to your generosity, and your understanding of the seriousness of the challenges that face children and young people in Colombia.



How has Children Change Colombia grown?

As our income has grown over the last 25 years, so has the size of our organisation. We now have 10 dedicated, professional staff.

With more staff has come the capacity to work more effectively. with more partner

organisations on more issues, and to reach more children.

Although spending money on fundraising and administration is essential if we are to become an ever more effective and professional defender of children's rights in Colombia, we have not spent our increasing income on higher admin costs or plusher offices.

In fact, as our expenditure has grown we have steadily increased the proportion that goes to our work in Colombia, rather than on fundraising, admin and governance costs.

Over the last five years an average of **81%** of our expenditure has gone in grants and support to our work in Colombia, significantly higher than the average of the previous 20 years.

Letter from the Director

Dear Friends

Children Change Colombia is 25 years old. Many of the children that we supported in our early years will now have children of their own.

Are these children living safer, happier childhoods than their parents did? For many, we think the answer is yes.

This is partly because of the support that their parents received from you during their own, difficult childhoods. You have helped thousands of young people find safety and love and develop the skills and confidence to establish fulfilling lives for themselves and come to have healthy and happy children of their own.

Yet many children in Colombia still face childhoods as uncertain and dangerous as children did 25 years ago.

One of the causes of this danger and uncertainty, the armed conflict between the government and the FARC guerrillas, may be about to reach a negotiated end. This is a significant moment for Colombia, and one of opportunity, but also of risk, for children and young people.

It is an opportunity because it could bring greater safety and more chances for children to develop their talents unhindered by the fear of violence.

It is a risk because the other threats to children that will remain could be overlooked in any 'post-conflict' euphoria.

We know that if a peace agreement is signed with the FARC, many other criminal armed groups, and the threats they pose to children, will remain. What's more, a peace agreement will not put an end to poverty or inequality overnight.

The response to these opportunities and risks must be the same. We must continue to create safe places where children, and the adults responsible for their protection, can be empowered to change their own lives and the lives of their communities.

If we can do this then today's children can begin to create a Colombia for their children that is truly free from conflict.

Colombia Diary

Our new Colombia-based fundraiser, Diana Bello, writes about a moving moment during a meeting of our partners in Cali.

Earlier this year I took part in the first meeting of all our current, and some previous, partner organisations. Over 3 days in Cali, Si Mujer, the host partner, ran workshops about 'Sexual and Reproductive Health and Rights', giving partners the knowledge and tools to provide support to the young people they work with, on 'invisible' issues like sexual violence and abortion.

Each of the 11 partner organisations was represented by young people who presented their work and talked about their greatest achievements since joining the project. There was one very emotional moment during one of these presentations. We had grown close as a group and one girl opened up and explained that she had been a victim of sexual violence by members of an illegal armed group when she was just fourteen years old. She told us how difficult it had been for her to recover from this, but that doing so was a huge achievement. For most of us listening, her story brought home the reality of life for some children in Colombia. But for others, a couple of young people from another of our partner organisations who are former child soldiers, it was the opportunity for them to ask forgiveness from victims of the armed conflict, a conflict in which they had been forced to play a role. The whole room came together in a big group hug; it was a very healing moment for us all.

The process of reconciliation and reintegration into society for all of our children and young people who have been victims of the conflict will be long and it's so important to continue strengthening our partners' work with them. The time has come to offer young people the opportunity to build and enjoy an inclusive, safe and peaceful future. I'm certain that Children Change Colombia is on the right track to support this process.
